(the "Redeveloper") for the implementation of certain improvements (the "Plan Improvements") contemplated by the Metro North Crossing Tax Increment Financing Plan, as amended (the "TIF Plan").

#### 11. <u>Parvin Road TIF Plan:</u> Consideration of the Funding Redevelopment Agreement between the TIF Commission and City of Kansas City, Missouri, in connection with the implementation of the Parvin Road TIF Plan, and other matters related thereto. *(Wesley Fields)* Exhibit 11

On November 8, 2000, after receiving the comments of all interested persons and taxing districts, the Commission, by Resolution No. 11-13-00, recommended to the City Council (the "City Council") of the City of Kansas City, Missouri (the "City") the approval of the Parvin Road Tax Increment Financing Plan (the "Plan") and the City Council did so on December 14, 2000, by Ordinance Number 001638, and did also designate the area described by the Plan as a redevelopment area (the "Redevelopment Area"). The Plan has been subsequently amended by a series of ordinances passed by the City Council (the "Parvin Road Tax Increment Financing Plan as amended shall hereinafter be referred to as the "Amended Plan").

The Amended Plan provides for the construction of, or improvements to, certain roadways, curbing, traffic signals, storm sewers, water lines, utilities and related public infrastructure improvements within and adjacent to the Redevelopment Area, as necessary to accommodate an expansion of the existing above ground industrial park and its underground industrial and commercial complex known as the Subtropolis, including the widening of NE 48 Street, beginning at Worlds of Fun Drive and continuing east approximately 3,600 linear feet (the "Road Improvements"),

The City desires to contribute Five Million Dollars (\$5,000,000) (the "City's Contribution") toward the costs of construction that relate to the implementation of the Road Improvements (the "Road Improvement Costs"). Commission desires to receive the City's Contribution and deposit it into a separate account dedicated for the purpose of financing the construction of the Road Improvements.

Attached to the TIF Commission Board Packet as **Exhibit 11** is Funding Agreement by and between the Commission and the City, which provides, in part, that (A) after the receipt of the City's Contribution or any installment thereof, the Commission shall deposit it in a Road Improvement Account. The Road Improvement Account (i) shall be segregated on the books and records of the Commission from all other money, revenue, funds and accounts of the Commission and (ii) the money therein, including all interest accruing thereto, shall be utilized to pay the Road Improvement Costs the Commission is obligated to reimburse, pursuant to the terms and conditions of a Redevelopment Agreement with Hunt Midwest Real Estate Development, Inc.

To the extent the Commission finds acceptable the terms of the Funding Agreement, staff and legal counsel recommend approval, subject to modifications accepted by the Chair, Executive Director and legal counsel.

# 21. <u>River Market TIF Plan</u>: Consideration of a First Amendment to the Cooperative Agreement by and between the River Market Community Improvement District and the and Commission, and other matters related thereto. *(Wesley Fields)* Exhibit 21

On November 10, 1999, after receiving the comments of all interested persons and taxing districts, the Commission, by Resolution No. 11199, recommended to the City Council (the "City Council") of the City of Kansas City, Missouri (the "City") the approval of the River Market Tax Increment Financing Plan (the "Plan") and the City Council did so on December 16, 1999, by Ordinance Number 991556, and did also designate the area described by the Plan as a redevelopment area (the "Redevelopment Area"). The Plan has been subsequently amended by a series of ordinances passed by the City Council (the "Parvin Road Tax Increment Financing Plan as amended shall hereinafter be referred to as the "Amended Plan").

The Amended Plan provides for the reimbursement of certain costs related to public infrastructure improvements contemplated by and located within the area described by the Amended Plan. On February 9, 2012, the River Market Community Improvement District (CID) and the Commission entered into a Cooperative Agreement, which provides for the implementation of certain improvements contemplated by the Amended Plan by December 2022 and the reimbursement of certain costs related thereto in an amount not in excess of \$825,000 ("Redevelopment Project Costs").

The City Council intends to consider the approval of the Eleventh Amendment to Amended Plan, which provides, inter alia, for certain modifications to the Redevelopment Schedule as it relates to the improvements to be undertaken by the River Market CID by extending such date of completion to December 2023 and the inclusion of all conforming changes within the Exhibits to the Amended Plan that are in furtherance of the foregoing modification (the "Eleventh Amendment Modifications").

Enclosed in the Commission's Packet, as <u>Exhibit 21</u> is First Amendment to the Cooperative Agreement by and between the Commission and the River Market CID, which incorporates the Eleventh Amendment Modifications.

To the extent the Commission finds acceptable the terms and conditions of the First Amendment to the Cooperative, staff and legal counsel recommend its approval, subject to modifications approved by the Chair, the Executive Director and legal counsel and subject to the City Council's approval of the Eleventh Amendment to the Amended Plan. Action recommended: APPROVE THE EXECUTION OF THE FIRST AMENDMENT TO THE COOPERATIVE AGREEMENT WITH RIVER MARKET COMMUNITY IMPROVEMENT DISTRICT, IN A FORM SUBSTANTIALLY SIMILAR TO EXHIBIT 21, RELATIVE TO THE RIVER MARKET TIF PLAN SUBJECT TO MODIFICATIONS ACCEPTED BY THE CHAIR, EXECUTIVE DIRECTOR AND LEGAL COUNSEL AND SUBJECT TO THE CITY COUNCIL'S APPROVAL OF THE ELEVENTH AMENDMENT TO THE RIVER MARKET TIF PLAN.

# 22. <u>Overlook TIF Plan:</u> Consideration of the Certification of Redevelopment Project Costs #14, and other matters related thereto. *(Heather Brown)* (Exhibit 22)

A plan for redevelopment known as the "Overlook Tax Increment Financing Plan" (the "TIF Plan") for an area designated therein as the redevelopment area (the "Redevelopment Area") was approved by the City Council of the City (the "Council") by its passage of Ordinance No. 200942 (the "TIF Ordinance").

The TIF Plan provides that the estimated reimbursable Redevelopment Project Costs related to the implementation of Projects Improvements described therein are approximately \$23,283,520, which include (1) approximately \$2,995,838 of Economic Activity Taxes and (2)(a) approximately \$2,995,838 of Additional City EATs, (b) approximately \$150,000 sales tax approved and allocated by the Public Improvements Advisory Committee (PIAC) and (c) approximately \$5,150,000 in sales tax recommended by the Central City Economic Development Board (collectively, the City's Additional Tax Contributions").

On July 9, 2021, the Commission, the City, the Redeveloper and Novak Birks, P.C. (the "Cost Certifier") entered into a Tax Contribution and Disbursement Agreement, which was amended on February 2, 2022 and February 3, 2023 (collectively, the "Tax Contribution Agreement"), and which provides, in part, for the procedures related to the certification of redevelopment project costs and the disbursement of the City's Additional Tax Contributions.

In accordance with the Tax Contribution Agreement and pursuant to the Cost Certifier's Report to the Commission #14 December 19<sup>th</sup>, 2022 (the "Cost Certifier Report"), which, with the consent of the City, the Redeveloper requested \$465,937 in costs and the Certifier certified \$428,573 of redevelopment project costs related to Concrete work, Site Utility, Electrical, Landscaping, and Design & Engineering work for reimbursement from CCEDI funds and questioned \$37,364 of Excavation/ Earthwork for being over budget. Based upon such certification and consent by the City, Central City Sales Tax contributed by the City to the Commission was utilized to pay such redevelopment project costs identified by the Cost Certifier Report.

In accordance with Exhibit B to the Tax Contribution Agreement, entitled, "Cost Certification and Payment Procedures", staff recommends that the Commission approve certification of \$428,573 of redevelopment project costs funded with Central City Sales Tax.

Action recommended: APPROVAL OF THE CERTIFICATION OF \$428,573 OF REDEVELOPMENT PROJECT COSTS IDENTIFIED BY THE OVERLOOK TIF PLAN TO BE FUNDED WITH CENTRAL CITY SALES TAX, AS HAS BEEN CERTIFIED BY NOVAK BIRKS, P.C. AND CONSENTED TO BY THE CITY OF KANSAS CITY, MISSOURI AND AUTHORIZE AND DIRECT THE CHAIR, VICE-CHAIR, OR EXECUTIVE DIRECTOR TO EXECUTE A RESOLUTION APPROVING THE SAME.
